Circular to Creditors

Big Shed Brewing Concern Pty Ltd (Subject to a Deed of Company Arrangement) ACN 160 802 906 ("Company")

Please be advised that on **20 March 2024** the creditors of the Company in a meeting convened pursuant to Section 439A of the *Corporations Act 2001* resolved by majority that the Company execute a Deed of Company Arrangement ("**Deed**").

The Deed has been executed by the Company and us as Administrators and takes effect from **21 March 2024**. Formal notice of the execution of the Deed is attached.

The terms of the Deed are as outlined in our report to creditors dated 12 March 2024 and include the following:

- the reinstatement of the directors' powers who now control the day-to-day trading operations of the Company. We are no longer involved with the business operations and will not be liable or responsible for any debts incurred by the Company on or after 21 March 2024.
- contributions totalling \$125,000 are to be paid into a Deed Fund by the Company's directors via payments of \$25,000 due on or before 30 June 2024, 30 September 2024, 31 December 2024, 31 March 2025 and 30 June 2025.

As a consequence of the second point, it is imperative that we finalise our determination of creditor claims as soon as possible and enclose a Formal Proof of Debt. If you have already submitted a Proof of Debt form you do not need to re-submit another.
